

Overview

Indian Chemical industry is the 3rd largest in Asia and the 6th largest in the world. It was growing at 5-6% over the last few years and expected to reach 8-9% growth in coming years. Domestic chemical industry is expected to reach USD 304 billion by 2025. Increasing urbanization are fueling the end consumption demand for paints, textiles, adhesives and construction, which, in turn, leads to substantial growth opportunity for chemicals companies. Further, the geo-political scenario of China is also pushing the global supply chain to expand away from China to India and South East Asia is also driving investment.

The Indian chemicals industry has a diversified manufacturing base and there is a substantial presence of downstream industries in all segments. Basic chemicals has over 50% share of total chemical production. Specialty chemicals and knowledge chemicals



forms 20% and 30% respectively.

Indian Chemical Industry comprises both small and large-scale units, and presently, there are about 70,000 chemical manufacturing units located in the country (Deptt. Of Chemicals and Petrochemicals-Draft National Chemical Policy-December 2013) a major component (in numbers) are covered in the small scale sector.

Indian Chemical Sector

Government recognizes chemical industry as a key growth element of Indian economy. It allows 100% FDI in chemical sector with some reservation. Manufacture of most of chemical products is delicensed. Gol also encourages setting up of "Centres of Excellence" and "Industrial Clusters" by providing R&D incentives and area based incentives.

Despite the current pandemic situation, the Indian chemical industry is enjoying an optimistic scenario, with the supply chain disruption in China and trade conflict among the US, Europe and China. Anti-pollution measures in China is also creating opportunities for the Indian chemical industry in specific segments.


